

**Snowfall in Shimla-Manali, rain in Chamba leads to power outages in several areas**



**Shimla:** The first snowfall of the year occurred in Shimla and Manali in Himachal Pradesh. The snowfall is still continuing. Meanwhile, it rained in Kangra. Strong winds have been blowing in Shimla since late last night. Continuous rain is also continuing in Chamba, and power outages have occurred in several areas. Cold wave conditions prevailed in Barthin, Hamirpur, Bilaspur, Una, Mandi, and Kangra. The minimum temperature remained below 5 degrees Celsius at 20 major locations in the state. The Meteorological Department has issued an orange alert for strong winds at a speed of 40 to 50 kilometers per hour and heavy snowfall in Lahaul-Spiti, Chamba, and Kullu districts on Friday. A yellow alert has been issued for thunderstorms with hailstorms and rain in Mandi, Kangra, Hamirpur, Bilaspur, and Solan. Snowfall is also expected in Manali, Kufri, Narkanda, and Solang Valley, in addition to Shimla city, on Friday.

**ED raids eight locations of accused and associates in nightclub fire case**

**New Delhi:** The Enforcement Directorate (ED) on Friday launched a major operation against the accused, Saurabh and Gaurav Luthra, in the infamous 'Birch by Romeo Lane' nightclub fire incident in

Goa. The ED simultaneously raided a total of eight locations linked to the Luthra brothers, three in Goa and five in Delhi. This action was taken on suspicion of money laundering following the devastating fire on December 6, which tragically claimed the lives of 25 people. According to reports, police investigations have already revealed that the Luthra brothers operate a network of 42 shell companies registered at the same address in Delhi. These companies are suspected of being used for the misappropriation of crores of rupees and money laundering. The Luthra brothers, who were recently deported from Thailand to India, may face further difficulties. ED teams conducted simultaneous raids in Delhi and Goa on Friday morning.

The two sides are also preparing to finalize another agreement on the

'security of information agreement'. Jaishankar said in a post on X that in his meeting with the EU member states' ambassadors, he discussed the "current state of the world where instability has become commonplace."

The External Affairs Minister said he stressed the need for a strong India-EU collaboration

that would safeguard the global economy from risks by cooperating on resilient supply chains and reassuring the international community

by providing humanitarian assistance, disaster relief, and other support. He said India and the EU need to "stabilize the global order through a robust trade, mobility, and security partnership."

Jaishankar said he was looking forward to the visit of European Council President Antonio

Luis Santos da Costa and European Commission President Ursula von der Leyen to New Delhi. Both

will also be the chief guests at the Republic Day parade.

He said preparations for the EU leadership's visit to New Delhi are well underway, but there are also challenges.

## Indigo flight from Delhi to Pune receives bomb threat

New Delhi: An Indigo flight from Delhi

to Pune received a bomb threat. Following the threat, the aircraft was thoroughly searched after landing at Pune airport, but no explosives were found. According to reports, the flight was scheduled to arrive at 8:40 PM, but it landed at Pune airport at 9:24 PM and was parked at 9:27 PM. The Air Traffic Control (ATC) then received information about a bomb threat. Reports indicate that a handwritten note threatening a bomb was found on a tissue paper in the aircraft's lavatory. Following the information, the aircraft was moved to an isolation parking bay, and the Bomb Detection and Disposal Squad (BDDS) was notified. Security agencies conducted a thorough search of the aircraft, but no suspicious objects were recovered. After the search, the flight was cleared for departure.

## Bomb threats received by schools in Ahmedabad and Noida, security alert issued

New Delhi: Panic gripped Ahmedabad after two prestigious schools, St. Xavier's and Sant Kabir, received bomb threats via email on Friday. Police and bomb disposal squads immediately rushed to the scene and conducted a thorough search of the school premises. No suspicious objects have been found so far, but all necessary security measures have been taken. The school administration informed parents and instructed them to pick up their children from designated safe drop-off points. Shiv Nadar School in Noida also received a similar threat via email. Police immediately increased security at the school premises and launched a search operation. According to police officials, the email appears to be a hoax based on preliminary investigations, but the investigation is ongoing from all angles.

## Significant Achievement: AIIMS performs first-ever laparoscopic Whipple surgery on an 11-year-old child

The All India Institute of Medical Sciences (AIIMS) has performed a laparoscopic Whipple surgery on a child for the first time. This achievement was highlighted during the 21st annual conference of the Pediatric Endoscopic Surgeons of India (PESICON 2026), organized by the Department of Pediatric Surgery at AIIMS. The Whipple procedure, medically known as pancreaticoduodenectomy, is considered one of the most complex surgical procedures in general surgery. This operation involves removing the head of the pancreas, a portion of the small intestine, the gallbladder, and the bile duct. Until now, this surgery was usually performed through open surgery, mostly in adult patients. Performing this surgery laparoscopically (using a minimally invasive technique) in a child is a first in India. According to AIIMS doctors, the 11-year-old girl has become the youngest patient in the world to undergo this complex procedure entirely through the laparoscopic method.

Professor Sandeep Agarwal, Head of the Department of Pediatric Surgery at AIIMS, described it as a transformative moment for Indian pediatric surgery. Speaking to the media, he said that children have different body structures, making such a complex surgery through minimal incisions extremely challenging. The operation lasted approximately eight and a half hours, with only four small incisions made on the body. This successful operation was led by Professor Dr. Anjan Kumar Dhua of the Department of Pediatric Surgery. The case presentation was appreciated by experts from across the country present at the conference.

**Brief News****Torpa Police Take Swift Action in Scooter Theft Case, Four Minors Apprehended**

**Khunti:** The police in the Torpa police station area have solved a scooter theft case within just 24 hours, apprehending four minors. This information was given by Torpa Sub-Divisional Police Officer Christopher Keretta in a press conference held at his office on Friday. He said that a scooter was stolen on January 5, 2026, from in front of a school in Dematoli under the Torpa police station area. A case was registered at the Torpa police station based on a written application given by the vehicle owner. A team formed under the leadership of Police Inspector Ashok Kumar Singh took swift action and recovered the stolen scooter (registration number JH 23 C 367) and another scooter (JH 23 C 344) within 24 hours. Two minors were apprehended in this case, who confessed to their crime during questioning.

**Biker Dies After Being Hit by an Unidentified Vehicle**

**East Singhbhum:** A young man on a motorcycle died in a road accident late Thursday night near Pinky Hotel, about 200 meters from the Ulidih police station. The deceased has been identified as Sirajuddin Ansari (35), a resident of Hayatnagar, Dimna Basti, Road Number 5, Ulidih, who lived in a rented house in Jamshedpur. According to his family, Sirajuddin worked as a driver at Spectra Super Alloys Limited company in Kandla. On Thursday night, after finishing work, he was returning home on his motorcycle. Around midnight, in the Ulidih area, an unknown vehicle hit him with great force, causing him serious injuries. After the accident, passersby informed the police. Ulidih police arrived at the scene and took the injured Sirajuddin to MGM Hospital, where doctors declared him dead. The police have taken the body into custody for post-mortem examination and have launched a search for the unknown vehicle. The deceased's younger brother, Fayaz Alam, said that Sirajuddin was the father of four children and the sole breadwinner of his family. He was originally from Chhapra district in Bihar. The sudden incident has plunged the family into mourning, and local residents are also deeply saddened by the tragedy.

**Seven-Year-Old Boy's Arm Saved at Paras Hospital Ranchi Through 'Limb-Saving Surgery'**

**Successful operation performed by Dr. Avkash Kumar and his team**

**Ranchi:** A miraculous surgery has been performed in the Orthopedics department of Paras HEC Hospital, Ranchi. Dr. Avkash Kumar, a renowned orthopedic consultant at the hospital, and his team successfully saved the arm of a seven-year-old boy. The boy's arm bones were fractured and protruding from his body after he fell from a swing at school. The injury was so severe that both bones of his right arm (radius and ulna) were broken and exposed. Examination revealed that soil and mud from the school playground had entered the open wound and the fractured bones. Dr. Avkash Kumar



immediately decided to perform emergency limb-saving surgery. In this complex procedure, the soil and infected debris were thoroughly cleaned from inside the bones. Then, both bones were successfully fixed in a single operation.

Dr. Avkash Kumar's timely surgery prevented the spread of infection and completely saved the child's arm. According to the medical report, the child's arm is now fully functional, and he is rapidly returning to a normal life.

The Orthopedics team received full support from the Anesthesia team during this surgery. Their expert care and continuous monitoring played a crucial role in the success of this limb-saving surgery. Dr. Avkash said that this was a "high-risk" case. Due to the presence of soil in the bones, there was a risk of osteomyelitis, a life-threatening bone infection, which could have rendered

the arm permanently useless. Timely surgery saved the child's arm. The hospital's Facility Director, Dr. Nitesh Kumar, said that in such serious and emergency cases, making the right decision at the right time is paramount. The skill, dedication, and promptness with which Dr. Avkash Kumar and his team handled this case are commendable. **Former Tata Steel senior official dies of heart attack during Saraswati Puja**

The Saraswati Puja organized on the occasion of Basant Panchami at the office of the Tata Workers Union, the recognized union of Tata Steel, turned into a condolence meeting on Friday when Jaydev Upadhyay, a senior former official associated with the union, suddenly passed away during the puja. 71-year-old Jaydev Upadhyay's health suddenly deteriorated during the puja. He was immediately taken to Tata Main Hospital, where despite all efforts by the doctors, he could not be saved. This tragic incident has cast a pall of gloom over the union office, Tata

Steel management, and the city's industrial sector. According to the information received, the Saraswati Puja program was underway at the Tata Workers Union office at around 10 am on Friday. Jaydev Upadhyay, who was participating in the puja, suddenly felt severe chest pain. His condition deteriorated rapidly, after which his colleagues present there immediately rushed him to TMH. At the hospital, he was describing his pain to the doctors when he suddenly fainted. Doctors tried to revive him by continuously giving him CPR for about an hour, but he was finally declared dead. Artisans climb makeshift stairways, painters add final touches and workers carefully align massive structures.

Amid this controlled bustle, Republic Day tableaux are taking shape, with every frame, colour and detail preparing to tell captivating stories on Kartavya Path.

This year's Jan 26 parade marks 150 years of Vande Mataram, and its spirit runs through every creation. On Thursday, media witnessed around 30 tableaux in different stages of completion, each reflecting India's past, present

and its aspirations. Nearly 10,000 people will soon watch them roll along Kartavya Path, while 2,500 artistes are set to perform, capping the visual spectacle on wheels.

One of the most striking displays is a tableau titled 'Operation Sindoor: Victory Through Jointness', which highlights India's military strength, with Rafale jets and Akash missiles on display. Nearby, Gujarat's tableau traces the journey of India from 1906 to 1947 under the theme of 'Vande Mataram', its structure anchored by a towering figure of Mahatma Gandhi.

Delhi's tableau pays tribute to the Prime Ministers' Museum while showcasing the capital's transformed skyline, featuring the new Parliament, Bharat

Mandapam, Signature Bridge and Yashobhoomi as symbols of a changing nation.

Other states, too, have brought their landscapes and legacies vividly to life. Bihar's tableau follows the journey of makhana - from pond to plate. "It took one month to make this whole thing," a carpenter said. Himachal

Ladakh showcases the engineering feat of Shyok Tunnel, Uttarakhand displays its traditional instruments and utensils, while J&K recre-

ates the charm of a houseboat. Dancers from Tamil Nadu will perform mayilattam, also known as peacock dance. "A team of 17 members is here from Chennai to perform," said Jyotsana, adjusting her costume with a smile.

Parasmal Solanki from Rajasthan will perform along with his 16-member team.

Nagaland's tableau features a massive hornbill. "We want everyone to know about Hornbill Festival," said Yangerla, a folk dancer. Jharkhand's tableau showcases the state's natural beauty and aims at attracting tourists, said Neha Agarwal, a state representative.

Karnataka's tableau, From Millets to Microchips, tells a story of holistic growth through scenes of a farmer family with millets, silicon crystals, a robot and a giant

microchip - linking agriculture with technology and innovation. Assam has transformed terracotta into visual poetry. Chhattisgarh's tableau pays homage to tribal heroes like Veer Gunda Dhur and Veer Narayan Singh.

## MHA notifies Census 2027 schedule, lists 33 questions

**NEW DELHI, AGENCY:**

The ministry of home affairs on Thursday notified the schedule for upcoming houselisting and housing phase of Census 2027, replicating each of the 33 questions that were proposed to be asked in Census 2021 before the pandemic forced its postponement.

The fields of information sought to be collected in the housing phase of Census, scheduled to be conducted between April 1 and Sept 30, include the building number; predominant material of floor, wall and roof of the census house; use of the census house and its condition; as well as household number.

Information will have to be furnished on total number of persons residing in the household, name and sex of the head of the



household; and if he/she belongs to the SC, ST or other category. Also included are fields pertaining to ownership status of the house; number of dwelling

rooms in possession of the household; and number of married couples residing in the household.

As regards amenities, respondents will need to

apprise the census authority - either digitally through the census app or during the enumerator's visit - of the main source of drinking water, main source of lighting, access to and type of latrine, waste water outlet and availability of bathing facility. Information will also be sought on availability of LPG or CNG connection in the household and the main fuel used for cooking.

Household amenities and facilities to be mapped shall include transistor, radio, TV, internet access, mobile phone or smartphone; and mode of transport. Respondents will also need to share details of the main cereal consumed in the household. The mobile number of the household (head or any other) will be collected but used only for census-related communications.

## Brazilian President dials PM Modi

**Reaffirm India-Brazil partnership; discuss global issues**

**NEW DELHI, AGENCY:** Prime Minister Narendra on Thursday had a telephonic exchange with Brazilian President Luiz Inacio Lula De Silva.

According to a statement by the ministry of external affairs, both the leaders reaffirmed their commitments to strengthen India-Brazil strategic partnership.

"Prime Minister Narendra Modi received a telephone call today from the President of Brazil, Luiz Inacio Lula da Silva. The two leaders reaffirmed their commitment to further strengthen the India-Brazil Strategic Partnership and take it to even



greater heights in the year ahead," MEA said.

"The leaders also exchanged views on regional and global issues of mutual interest. They also underscored the importance of reformed multilateralism in addressing shared challenges," it added. During the exchange, PM Modi also invited Lula to visit India at an early date.

## Engineer shoots wife accidentally distressed by death, he kills self

**AHMEDABAD, AGENCY:**

Congress Rajya Sabha MP Shaktisinh Gohil's nephew Yashrajsinh Gohil allegedly shot his wife "accidentally" in the head with a licensed revolver in their Ahmedabad flat late Wednesday and then turned the gun on himself, police said.

The shooting unfolded in their fifth-floor apartment between 10.30pm and midnight, ACP Jitendra Brahmabhatt said. Yashrajsinh (35) was a Class-I officer with Gujarat Maritime Board. He had married Rajeshwari (30) last Nov.

Citing a statement by Yashrajsinh's mother Devyaniba, cops said while the two were in the bedroom, a bullet accidentally discharged from Yashrajsinh's revolver and struck Rajeshwari at the base of her head.

Devyaniba said her son rushed to her room and said an ambu-



lance needed to be called. Police records indicate Yashrajsinh called 108 emergency ambulance service at 11.42pm. Paramedics arrived and declared Rajeshwari dead. According to Devyaniba's statement, Yashrajsinh appeared deeply shaken after hearing that his wife had died. Moments later, a gunshot was heard from the bedroom.

## Low Vitamin D may worsen Dengue outcomes, global study raises questions for India

**NEW DELHI, AGENCY:** A clinical study from Colombia, published in the Indian Journal of Medical Research, the peer-reviewed journal of the Indian Council of Medical Research (ICMR), has found that low vitamin D levels are linked to more severe dengue, a finding with clear relevance for India, where both dengue and vitamin D deficiency are widespread.

Dengue remains a recurring public health challenge in the country, especially during the monsoon, when hospitals see sharp rises in patients with high fever, falling platelet counts and bleeding complications. While many recover with supportive care, a significant proportion deteriorate rapidly, and predicting severity remains difficult.

In the Colombian study, researchers analysed blood samples from nearly 100 laboratory-confirmed dengue patients, classified by disease



severity, and compared them with healthy individuals. They measured serum vitamin D levels along with miRNA-155, a molecule that regulates immune and inflammatory responses. Patients with milder dengue had higher vitamin D levels, while those with warning signs or severe disease showed significant deficiency.

At the same time, miRNA-155 levels rose steadily with increasing severity, indicating an exaggerated immune response. The study also found an inverse relationship between vitamin D and inflammatory markers such as

TNF-alpha and interleukin-6, both linked to severe dengue and complications like dengue haemorrhagic fever.

Commenting on the findings, Dr R. Goswami, professor of endocrinology at the All India Institute of Medical Sciences, said the study strengthens earlier evidence linking low vitamin D with severe dengue, particularly dengue haemorrhagic fever. "What this study adds is a possible disease mechanism through microRNA-155, which is involved in immune dysregulation via Th1 and Th2 pathways," he said, adding that it is prudent to maintain normal levels.

Doctors say the findings resonate with Indian clinical experience. Dr Pankaj Soni, principal director (internal medicine) at Fortis Escorts Heart Institute, said low vitamin D is associated with bleeding and complications and may worsen inflammation and viral replication, making it a modifiable risk factor but not a treatment.

## Triple talaq-halala FIR puts focus on legal grey area

**NEW DELHI, AGENCY:** When police in UP registered an FIR on Dec 9, 2025, it was not just another complaint under the 2019 Triple Talaq law. The allegations were shocking and went further, into a grey zone the law has never squarely addressed: What happens to women after talaq is pronounced.

According to the FIR filed in Amroha's Said Nagli, the woman, after being divorced through instant triple talaq, was pressured by her husband, her brother-in-law and clerics to undergo "halala" multiple times so she could be returned to the marriage. An exception that permits a divorced Muslim couple to remarry, the practice of halala often involves planned, short-term mar-



riages - even arranged one-time encounters - to facilitate consummation of the woman with another man, enabling the former couple to reunite.

The woman's complaint detailed the ordeal. She said she was "gang-raped under false pretenses of halala

carried out under threats, intimidation and coercion".

Police have invoked the law banning instant triple talaq - sections 3 and 4 of the Muslim Women (Protection of Rights on Marriage) Act, 2019. Multiple provisions and relevant sections of BNS that deal

with rape, aggravated hurt, criminal intimidation and criminal conspiracy, have also been added.

In the initial FIR, there are three accused: Her husband, his cousin and a hakim (traditional healer.) Since then, police have added more accused to the list.

Amroha police told media that one accused - her husband - had been arrested so far. "The FIR has been registered on the basis of a written complaint. Further action will depend on corroboration and evidence," SHO Vikas Sahrawat said. Amroha police are on the lookout for others on the run, he added.

This week, based on Zubaida's (name changed) age at the time of her marriage, police added multiple

provisions of the Pocso Act to the FIR, expanding its scope. (The move, incidentally, also brings into focus an unresolved legal grey area, as Muslim personal law is not codified and does not prescribe a minimum age, instead linking marriageability to puberty. The issue remains unsettled by the Supreme Court so far, with courts in different states taking conflicting positions.)

The FIR covers several years of alleged abuse, assault and rape. Zubaida told police she was forcefully married off in 2015 at the age of 15, and subjected to pronouncements of instant triple talaq twice - once in 2016, and again in 2021, followed by three coerced reconciliation attempts through halala.

## Travel and Cultural Sublimity

In Goa, the sun sets and rises later. Nights and mornings are a little cooler, but the sun shines brightly during the day. The weather is pleasant. Spring has arrived on the trees. Mangoes are laden with blossoms. The mango trees are very tall, and coconut trees are competing with them. There are jackfruit, jasmine, black pepper, and hundreds of other plants I don't recognize. Almost every house is

surrounded by trees. As I climbed a hill during my morning walk, Goa appeared immersed in hills and trees. I heard the sounds of mountain birds, but the birds were few in number compared to the number of trees. Crows haven't been seen yet, there are pigeons, and even mynas. How is it possible for people to come to Goa and not see the sea? I went with my friends to two beaches—Mirabar and Donapaua, both in Panaji.

Donapaua has been artificially landscaped. A fee of fifty rupees is charged, and you can enter. It's said that the film "Ek Duje Ke Liye" was shot here. In Mirabar, gentle waves crash onto the shore. The sand is abundant, and you can stroll along the shoreline for long stretches. Walking on the waves is a joy. I ventured a little deeper into the sea, my feet sinking into the sand. When the rays of the setting sun shine on the waves, it's hard to focus

on them. Goa was ruled by the Mauryas, Chalukyas, and Satavahanas, before the Portuguese conquered it in 1510. They ruled for 450 years. Goa gained independence in 1961 and became part of India. Dr. Lohia is highly respected here because he first raised his voice for Goa's independence in 1946. Christianity spread after the Portuguese arrived. Old Goa is home to 15th-century churches. When I visited the Basilica

of Bom Jesus, its grandeur captivated me. Christian monuments have existed and are still vibrant. Opposite it is the cathedral, built in the 17th century. King Dom Subastio of Portugal commissioned its construction. Spread over thousands of acres, this cathedral houses numerous prayer halls. The campus is covered with coconut trees. There is an archaeological museum here. The name Old Goa evoked Old Delhi in

my mind, and I assumed Old Goa would be as dirty as Old Delhi. But its cleanliness and serenity captivate. Old Goa is also known as Rome of the East. Cannons are placed in front of the museum. These cannons also represent the triumph of the colonial empire. India experienced various princely states, and their internal conflicts provided opportunities for outsiders. Today, India's unity requires multicultural unity.

## Australian Open: Alcaraz defeats Moutet in straight sets to reach pre-quarterfinals

This was Alcaraz's 100th Grand Slam match, and his record now stands at 87 wins and 13 losses, matching the record of tennis legend Bjorn Borg.

Sarfaraz Khan has been in tremendous form lately. He created a sensation in the seventh round of the 2025-26 Vijay Hazare Trophy by scoring a half-century in just 15 balls against Punjab. This was the fastest half-century scored by an Indian batsman in List A cricket.

During this time, Sarfaraz broke the joint record of Abhijit Kale of Maharashtra (half-century in 16 balls against Baroda in 1995) and Baroda all-rounder Atit Sheth (half-century in 16 balls against Chhattisgarh in 2021). In the Vijay Hazare Trophy, Sarfaraz was the highest run-scorer for Mumbai. He scored 303 runs in six innings, with an average of 75.75 and a strike rate of 190.56. Furthermore, Sarfaraz's bat also shone brightly in the 2025-26 Syed Mushtaq Ali Trophy, where he was Mumbai's second-highest run-scorer. He scored 329 runs in seven matches, with an average of 65.80 and a strike rate of 203.80. Sarfaraz last played for India in a Test match against New Zealand in November 2024, but since then he has been consistently performing brilliantly in domestic cricket. Therefore, he is now changing his weight category and preparing for the Los Angeles Olympics. Ravi may now compete in the 65 kg weight category instead of 57 kg. The country has high hopes for him to win a gold medal in the next Olympics. The wrestler says that he cannot be content with just a silver medal. His goal is to win gold. Ravi gained recognition at the 2018 Under-23 World Championships, where he won a silver medal in the 57 kg weight category. In 2019, he secured his place in the Tokyo Olympics by winning a bronze medal at the World Wrestling Championships. Ravi is also a winner at the Asian Championships, having won gold medals in 2018, 2020, and 2021. After the Tokyo Olympics, Dahiya also won a gold medal at the Commonwealth Games in 2022. While his father, Rakesh Dahiya, is a farmer, his uncle, Mukesh Dahiya, has been involved in wrestling.

### Australian Open: Sabalenka defeats Potapova in a tough match to reach the pre-quarterfinals

World number one Aryna Sabalenka has overcome her first major challenge at the Australian Open, advancing to the round of 16. In the third-round match played on Friday, Sabalenka defeated Anastasia Potapova in straight sets, 7-6(4), 7-6(7). In the match held at Rod Laver Arena, Potapova played excellent tennis and gave Sabalenka a tough fight. Potapova, who recently changed her citizenship from Russia to Austria, represented the Central European country brilliantly in the opening match. In the second set, Sabalenka was trailing 0-4, but then Potapova broke serve three times to take a 6-5 lead, bringing the match to a thrilling point. However, in the decisive tiebreak, Potapova could not capitalize on four set points, which ultimately cost her the match. Sabalenka showed composure at crucial moments and created a match point with a drive volley. Finally, with Potapova's backhand going into the net, the match went to Sabalenka. After the match, Sabalenka said, "She played incredible tennis. I was under constant pressure, and honestly, there are days when you just have to hang



in there and fight. Emotionally, I was quite confused, my mind was somewhere else, my hands were going somewhere else. But somehow, magically, I managed to win this match." The four-time Grand Slam champion Sabalenka has reached the fourth round at Melbourne Park for the sixth consecutive time. She won consecutive titles here in 2023 and 2024. In the pre-quarterfinals, Sabalenka will face Canada's 17th seed Victoria Mboko, who made her Australian Open main draw debut and reached the last 16 by defeating Clara Tauson.

Sam Billings was the only other batsman to score more than 200 runs. With the new contract, Warner, who is the fourth-highest run-scorer in the history of T20 cricket, will be seen playing in the BBL even after

turning 40. After signing the contract, Warner said, "It was certainly a challenging year for us. We are a much better team than what we showed on the field this season and we couldn't perform consistently. But the support of our fans, who turned up in large numbers for every match, was crucial in my decision. I feel I still have a lot to offer to this team and this game. I was quite comfortable with my performance and proud of keeping the team in contention. We have started reviewing the season and are making the right plans for a strong comeback in BBL 16."

Sydney Thunder General Manager Trent Copeland said that retaining Warner was an easy decision. He said, "We are thrilled that David Warner will be staying with us for another season. He had a fantastic year. He has been one of the world's best T20 players for the past 15 years and remains one of the BBL's top batsmen. His fitness is excellent, and his hunger and leadership qualities to drive the team forward after a disappointing season are as strong as ever."

### Tilak Varma expected to be fit for T20 World Cup
